No guardia casualties.

MISCELLANEOUS

The following are extracts from the "MONTHLY RLCORD OF EVENTS" of the Eastern Area, commanded by Colonel L. L. Leech, G.N., for the month of September 1931:

"" The Northern Department was more than normally active, during the period, in maintaining peace and good order, incident to the wholesale discharge of hundreds of negroes from the employ of the local fruit compant. The Department Commander, Northern Bluefields, and his officers handled this situation in a most satisfactory manner. The absence of violence and unlawful assembly during this tense period is due to the activity and efficiency of these officers. The only abnormal conditions requiring action in the Southern Department were a few attempts to organize unlicenced political meetings in the streets of Bluefields. The parties involved were required to comply with the law, and meetings were properly controlled.

The general state of the territory occupied is quiet. There are two frontier points in this area which are potential trouble spots. Particular note is made of the fact that since Kisalaya has been garrisoned by Guardia troops during this period there has been no reliable news, or even rumors of bandit activity in that section. The establishment of the post of Kisalaya is believed to be a most valuable military addition to the area, in its denial of bandit approach from the northwest.

The bandits reported in the vicinity of Casa Vieja are not believed to be a formidable well organized for . Plans are being concluded for increasing the post of Neptune Mine to a strength of 20 enlisted, with an officer in charge, and one radio lieutenant on duty. This force will permit of active patrolling, and it is hoped, will check bandit deprodations in the Neptune Mine region.

In the general trend of business depression in this area during the past year, it is noted that a slight, but perceptible feeling of optimism exists, specially among the business mon of Bluffields. Some of the larger business concerns have even been able to report slight increase in turn over stock. The hope of the general public for better times is always based on the possibility of construction of the Nicaraguan Canal.

There is no friction between the Guardia and civil population.

"" Political situation: During September, Bluefields has witnessed more political activity than in any other monthly period for the past year. The Vice President's visits to Puerto Cabezas, Rama and Bluefields have sharply focused the attention of political agents to the probabilities of success in the approaching elections. The situation has been active, but properly controlled by the Guardia, and without acute interest.

The weather has been unfavorable for patrolling. Increased storms and unusually early heavy rains.

Roads and trails, such as exist, have been very poor. ""

The following report covers the contact of Captain G. A. Williams and Somoto (NA) guardia patrol with a bandit group at Naranjo on October 3, 1931:

On receipt of information that a group of about forty bandits under Colindres and Salinas, proceeding from the Northwest, had passed south of Somoto during the night of October 2-3, a patrol consisting of myself and the following named enlisted men cleared for Zapote Mountain (168-348) at 0730 October 3rd:

- 2. Tracks f the group were picked up near 165-349 and followed to Zapote Mountain (168-348) where the group split up into small groups proceeding by various trails toward the southwest. The patrol followed a group of apparently eight or nine up a hidden trail and around the western slope of Somoto Mountain to the vicinity of 167-344 where the group reformed and proceeded southwest, avoiding all houses. At 1430 when the patrol was at the lower edge of a corn field located on a mountain side, a thin column of smoke was detected in the woods near the upper edge of the field. By advancing up the mountain side through the corn field the patrol was able to reach a position within approximately forty-five yards of the main group of bandits before being observed, among which group it was latter learned were Colindres, Salinas and other minor Jefes. The camp, located in the woods at the upper edge of a corn field near Naranjo (165-343), was flanked on two sides and in rear by higher hills on which were located outposts. The fact that the bandits had just made camp and were heating water for coffee probably accounts for the fact that the patrol was able to approach through the corn field and pass directly between two outposts without being observed. The bandits attempted to offer resistance with rifles, revolvers and dynamite bombs, but when the hills to the flanks and rear were bombed with rifle grenades, they apparently bolieved they were surrounded and fled in various directions. The arms of the group also included two Thompson Sub-Machine guns, but no attempt was made to employ them. The bodies of two unidentified bandits were found in the camp and numerous blood trails. Five distinct blood trails led from a position occupied by a group of about fifteen bandits at which first burst of three machine guns had been directed. On October 8th three additional bodies were found by a native on his property located a short distance northeast of the scene of the contact.

Captured: 2 rifles Krag, Nos. 276605 and 319237. 2 rifles Remington, 10 dynamite bombs, 12 dynamite sticks, 132 rounds miscl. ammunition, 7 cutachas, 1 rifle grenade discharger, 1 leather rifle grenade carrier, 3 saddles, 4 briddles, 2 horses (later returned to owners from whom stolen). 12 blankets, 9 capotes, 4 hammocks, 10 haversacks. Large amount clothing and food. Miscellaneous articles such as canteens, knives, hats, see. In addition to two horses captured, two others were killed during contact.

4. The conduct of all onlisted members of the patrol was excellent. Although the bandit tracks then picked up by the patrol at 0830 near 165-349 were between five and six hours old, according to a native prisoner who escaped from group during firing and other indications in the camp, the bandits had arrived at the scene of the contact less than an hour before the patrol caught up with them at 1430.

In obedience to verbal orders from the Commanding Officer, Yali, Nic., I cleared Yali with fifteen enlisted men at 1.10 p.m. to operate in the east, as per reports received we knew that a bandit group passed through Rio Arriba at 7:00 a.m., same day. We passed through Coyolar and arrived Rio Arriba at about 4.30 p.m. There I had information that the bandits had cleared in direction to La Sotana. In Buena Vista of Rio Arriba we camped for the night.

2. 11 October

Cleared Buena Vista at 7:00 a.m., passing through La Sotana, Rio Negro, Rio Grande and arrived to San Rafael at 3.10 p.m.

3. 12 October

At 8.20 a.m., cleared San Rafael and arrived Yali at 12.30 p.m., 12 October 1931.

No other events uring the patrol.

Upon verbal orders received from the Department Commander I cleared Juigalpa for Santo Domingo, Chontales, on the 16th September 1931, arriving in Santo Domingo on the 17th of the same month. 2. On the 20th of September I cleared Santo Domingo on a reconnoitering patrol for the mountains and inspected the following places: Curinguas, a place four leagues from Santo Domingo, making that distance in six hours. From Curinguas we went to Timuli, a distance of two leagues, taking us three hours to make it. From Timuli to Calamate, three fourths of a league, making it in one hour. From Calamate to Corro Masana, two longues and a half, three hours and forty-five minutes, from Corro Macana to Amores dol Sol, distance of one loague and half, making it in two hours. From amores del Sol to Aremitas, one league and a half, making it in two hours and fifteen minutes. From Architas to Archas four leagues, time six hours.
From Architas to Archas four leagues, time six hours.
From Archas to Cerro del Mono, one fourth of a league,
time fifty-five minutes, from Cerro del Mono to Paso del
Rio Grando at Caña Brava, we crossed this river and headed to the encampment of El chiote, we explored this said
encampment, and did not fit cany sign of bandits in those
places, and took us twenty four hours for this inspection.
There is a distance of two leagues from Cerro del Mono to
El Achieto. From El Achieto I made a crossing to a point
called Quiscure, taking us two days to racke this trip to called Quiscura, taking us two days to make this trip to that point, making a thorough inspection as best as it was possible. From Quiscura I wont to Tibuli, crossing Siquia River, and taking us two days in this trip, from this place I cleared for Santo Domingo, taking eight hours in this trip. 3. The patrol was made of the become Lieutenant antonio Terecro, G.M., one non-commissioned officer and seven rases. There was no sign of bandits in any of the places where the patrol went through. 5. In compliance with the reference I cleared Boaco at 0732 Sept. 21, 1931 with a petrol of five enlisted for Camoapa with mission to investigate and report on trails and river crossings leading from Camoapa to Rio Murra and Rio Grande . 15

15121 arrived Camoapa. Questioned several persons from La Tablazon-Los Encuentros vicinity regarding recent bandit activities in that region and was informed that all was quiet.

07022 cleared for La Trinidad via El Congo and Las Lajas making camp for the right in La Trinidad at 17022. Everything quiet.

O6423 cleared for El Loro via Masigue and La Union make ing camp in El Loro at 15023. Information received and verified that Pedron upon entering Department that the last time crossed the Rio Grande at El Platanar proceeding down via Montes Verdes and San Antonio, and upon leaving crossed Rio Murra at El Sajino coming from San Antonio and proceeding to El Javio and La Corona. From El Sajino bandits cut their own trail to El Javio. Since then there has been no bandits in that area.

07022 cleared for Los Encuentros via boat as all trails from El Loro to that point are indirect and pass so far from the river that it would be impossible to obtain information on crossings. In El Sajino investigated camp where bandits spent one night but nothing of any military value could be found. Search was made for some animals reported to have been left there by the bandits but found no trace of them. Cleared for Los Encuentros arriving at 10024 and proceeded to La Tablazon afoot arriving 12024. Report received that bandits had been in that place recently also found to be false. Cleared for Los Cimientos at 12024 arriving and making camp at 16024. Everything quiet and trails very bad.

06325 cleared for junction of Rio Grande-Rio Negro rivers via boat making camp in house near junction at 16025.

07026 cleared for Los incoentros via boat arriving and making camp at 17226. Several nen were interviewed who had been captured by bandits in august and used to carry cargo but nothing of any value could be ascertained.

06027 cleared for El Codo via boat arriving and making camp for the night at 17327.

05028 cleared for Camoapa via San Miguel arriving 11128 and cleared for Boaco arriving 18029.

- 2. In the entire area patrolled there were no signs of recent bandit activities of any kind. I believe that the Alcalde of Camoapa is the responsible party for the false reports that have been received of late and have explained to him as well as to the people of Camoapa the damage done by submitting false information to the Guardia. The Indians living in the Rio Murra-Rio Grande vicinity are exceptionally friendly towards the Guardia and it is believed that better cooperation can be expected from them in ease the bandits enter the Department again.
 - 3. The Rio Grande can be crossed at the following places proceeding up river from Vora Cruz:

El Platanar, trail leading from Vera Cruz-Los Encuentros main trail to Montos Verdos. Los Encuentros, trail leading from El Platanar to La Tablazon and Boaco. Los Cimientos, only on Chontales side, one trail leading to La Tablazon and other to La Corona and Boaco. El Tigre, only on Matagalpa side, trail leading to Siquia and Vera Gruz. Saiz, only on Chontales side, leading to main trail from Salto de Loya to Boaco. Junction of Rio Megro-Rio Grande Rivers, only on Chontales side, leading to main trail from Salto de Loya to Boaco. Salto del Loya, trail leading from Matiguas and branching off at Salto del Loya, one trail leading to Boaco and other to Tierra Azul. Vaghas, only on Chontales side, one trail leading to Tierra Azul and other to La Corona and Boaco. From this point to Tierra Azul is plain and crossing can be made practically wherever wished.

The Rio Murra can be crossed at the following places: proceeding up river from Los Encuentros:


El Sajine, leading from La Union to Sim Antonio. El Loro leading from Cambapa to Sam Antonio. Cusucas, leading from Cambapa-Los Encuentros main trail to Sam Antonio and Ameros del Sol. El Mono leading from Cambapa-Los Encuentros main trail to Ameros del Sol. El Achiete, leading from Cambapa-El Loro main trail to mas. Caia Brava, leading from Cambapa-El Loro main trail to Aronas. El Codo, leading from Cambapa to Betulia and Aronas. Caña de Yuca, leading from El Godo-Cambapa main trail to Betulia and Amoros del Sol.

The trails in the entire Rio Hurra-Rio Grande area are very bad and in places impassable.

Practically all travel is done by river.

at the present time the Rio Grande is practically impassable except by boat and the Rio Murra from Los Encuentros to El Codo.

1. The following is a report of the contact in the vicinity of La Muta (192-358) at 1700, 18 Oct. 1931.

2. Station of Patrol. Totogalpa, Nicaragua.

3. Mission of Patrol.

The patrol cleared in compliance with verbal orders from the District Commander, with instructions to sook and destroy a group of arried bandits reported in that area. The patrol cleared at 1400 on 18 October, 1931, with the following 1 68 Officer and onlisted men:

4. Upon clearing Totogalpa, patrol used main trail to Yalaguina, for about one mile, then cut off to the left and followed this trail for about two leagues when patrol took a trail to the right. This trail had appearances of being seldon used. After following this trail for about one league. Point reported that a trail crossed and tracks were seen to be going to the left. Patrol immediately took this trail and followed it through very rough ground for distance of about three quarters of a mile.

Most of this distance was covered in a low crouching positions as the trail was heavily grown over and showed very little use. On the side of the trail in a cane patch, a steer with front feet tied was seen; just after passing the steer about of fundred yards chead, a house top was seen. The patrol immediately moved forward. As the house was located on the top of a steep hill, some of the distance was covered in the open; at a point just in front and after the point had gained top of hill, patrol was fired on; the point took position and returned fire, with two rifles and one STMG. Rest of patrol, ex-

cepting rear guard was noved on line of fire. I took
position with the Rifle Grenadier, and directed the discharger of two grenades. The contact lasted about seven ninutes, I judged that the bandits fired between thirty to forty rounds and then ran scattering into the brush, after fire had ceased, patrol moved forward and found one dead bandit. A large quantity of beans and tortillas had been prepared for their meal; all of this was destroyed, and the shaes were burned. Gould not follow bandits for any great distance on account of heavy underbrush and the approach of darkness.

5. <u>Wearons employed by Guardia:</u> One STLIG., One rifle Grenadier and 8 rifles.

Worpons employed by bandits: Rifles and Escopetas (Shotguns).

- 6. <u>Captured articles:</u> Four hats with bands, two cutachas.
- 7. The bandit group constant of about ten men, armed with rifles, escopetas and cutachas, and several pistols. The group is known as the Catalino Vargas group. The dead bandit was identified as Candido Gomez.
 - 8. <u>Casualties:</u>

Guardia: None.

Bandits: 1 man killed.

- 9. Discipline observed by the Guardia in this contact was excellent, all members quickly and without thought of hesitation obeyed the orders of the Patrol Germander.
- 10. It is highly recommended that Cabo Martinez V., #933 be commended for his handling of the Point; although under fire Cabo Martinez showed coolness in placing his men in a position that was of great importance to the manuvering of the main body.

- 1. At 1030, 6 Octuber 1931, the Alcalde of Yali reported to me that the Juez de la Mosta of El Tigre had been inand reported a group of bandits in El Tigre. It seems that this Juez was in very much of a hurry to clear out, for I have not been able to locate him up to the present time. However, on the strength of this report a patrol was cleared at 1100, 6 October 1931, to investigate this report. The patrol consisted of Licut. Bryson, twenty six enlisted and myself.
- 2. Haria Centeno, a resident of El Tigre, reported that a short time before my patrol arrived in El Tigre three bandits had been in her home and that htey had gone away in three different directions. This was verified by a boy about the age of fourteen years. These men were reported to have been carrying machetes and that none had fire-arms.
- as search of the vicinity was made, but as these men had taken to the brush in different directions there was not much left for us to follow up. After about an hour I returned to Yali with my patrol.
- 4. The boy reported that C lindres had been there in El Tigre sometime during the morning, but this could not be verified and I am of the opinion that the boy was mistaken..
