

10 DECEMBER 1931

Lieut Trosper, Lieut Whotehead (MC) and Jalapa (NA) guardia patrol cleared Jicaro and arrived Apali.

Jefe de Canton of Las Mosas 221-376, near Jicaro and seven other citizens armed with working machetes attacked a foraging group of 12 bandits armed with pistols and cuttachas under Jefe Florentin Quintero. During fight one bandit was wounded and captured named Leonidas Lopez. Other members of group retreated toward Ologalpa. The captured bandit stated that the foraging group had received orders to prepare a large amount of beef and other food stuffs in preparation for the return of a large bandit group in the Jicaro area.

Bandits were pursued by patrol and lasso by another patrol under Lieut Livermore. Further contact could not be made as bandits scattered in all directions.

03313 December 1931 cleared Leon with Lt. Cuadra and twenty five enlisted on combat mission to El Jicaral which station had been abandoned by Sub-Tnte. Castrillo, G.N., and twelve enlisted with instructions to gain contact with group which it had been reported had ransacked El Jicaral, on the night of 12 December 1931.

08013 arrived at end of railroad at Las Trozas and arrived at Madroñal at about noon same date, where the patrol was fed. Cleared Madroñal at 1400 and passed through Las Brisas at about 1700 and arrived El Jicaral at 23113 same date. Distance travelled about sixty miles. Upon arrival El Jicaral found the Guardia barracks in flames, and the town deserted. Bandits had burned all Guardia property, and had taken two Krag rifles that Lt. Castillo claimed to have buried.

14 December 31. Rested patrol and fortified church to be used as barracks, as there were no other buildings in the town suitable for purpose. Cleared off all brush within radius of one hundred yards of church, as a field of fire, and cleared space to be used for plane pick up.

07015 Cleared El Jicaral with Lt. Cuadra and twenty five enlisted and patrolled to Cerro Negro, covered ridge running North into the basin of Rio Agua Fria, and North of Santa Rosa without incident where camp was made for the night, at the finca of one Aquilino Rosendo.

06016 Cleared camp and proceeded West, forded Rio Agua Fria, and arrived at Buena Vista at about noon where patrol was fed. Cleared Buena Vista at about 1400 and headed South, crossed trail that runs east and west from Rodes to Carrizal and arrived at Tierra Blanca at about 1900 same date where patrol camped for the night without incident.

07017 Cleared camp and arrived at Rodes and arrived at El Cofredea where it was learned that Colindres had been camped for five days, prior to his attack on El Jicaral. Patrol made camp at the finca of Narciso Vallejos, who reported that Sandino had offered him a Captaincy in his army, fifty dollars in cash, and a forty five automatic pistol. (This man was formerly a lieutenant of Sandino and was used as a guide by Colindres when he entered El Jicaral). This same man warned Lt. Castillo that Colindres was at El Cofredea and that he intended to enter El Jicaral. Vallejos reported that Colindres bandit gang numbered about one

hundred and fifty men, including several boys, and that they were all armed with 38 Winchester repeating rifles, with plenty of ammunition, and that he had several automatic weapons, the makes of which he was not certain.

Patrol cleared El Cofrades at about 1500 and arrived at El Jicaral at about 21017.

18018. Spent day in El Jicaral resting patrol. Planes came over at about 10.30 a.m., and picked up message for Leon.

06019. Patrol cleared for Mira Flor, Cerro del Tigre and returned to El Jicaral without incident or bandit information.

20 Dec. 31. Planes came over and dropped message from the Department Commander of Leon. Made pick up poles and station and sent out patrols in search of food.

07021. Lts. McDonald and Cuadra with twenty five enlisted cleared camp for Las Pilas, Tigre Negro and vicinity of Achuapa and returned without incident. Planes came over patrol both in am. and pm. At Tigre Negro one Chano Alvarez, reported that Colindres had, in the name of Sandino, offered him fifty dollars cash, a forty five pistol and a high position in his army of liberty, if he would join the cause. This man was formerly a bandit jefe, and jefe of a group that ranged around El Sauce, San Nicolas and El Jicaral. Said to still have arms.

06022. Lt. Cuadra and eight enlisted cleared camp with Juez de Hesta of Valle de Asacialpa and returned at 1700 with six prisoners for killing two cows, stealing a horse and some corn the property of one senior Luis Acuña. Prisoners turned over to Juez Local of El Jicaral. No bandit information.

23 Dec. 31. Patrol in camp. Lt. MacDonald and fifteen enlisted cleared El Jicaral at 2400 and arrived at Madroño at about 0400 24 Dec. 31. Cleared Madroño Finca at about 0600 and arrived San Antonio at about noon, proceeded to Las Trozas where took train to Leon where patrol arrived without incident 18124.

1. Colindres entered El Jicaral between seven and seven thirty p.m., with a group variously estimated at between eighty and hundred and fifty men.

2. After the Guardia barracks had been burned this group split into two groups, Colindres turning North to Palo Blanco, on the El Sauce trail, and Umanzor went South to Milpa Vieja, where according to best information available, a junction was made with a group under one Juan Manuel Morales, who had come south from Salala, and who had raided some bull carts on the Sauce trail.

3. Reported that Lt. Castillo had been in communication with Colindres by various persons in El Jicaral, who had seen the communications, and that the Guardia retired from Jicaral some four hours prior to the arrival of Colindres, who did not expect trouble, as he was at the head of his bandits when they entered Jicaral and headed straight to the Guardia barracks.

4. Reported by Narciso Vallejos and Chano Alvarez, and the residents of El Jicaral, that Colindres had stated that Sandino was on the Esteli-Jinotega border, and that Pedron had arrived in the Villa Nueva area from Chontales. That Sandino had decided to stop railroad construction and would exert every effort to that end, and that a big drive would be made on Chinandega.

The following order for the creation of the New District of El Sauce, Department of Leon, is quoted for general information:

OPERATIONS ORDER NO. 1:

1. Effective December 20, 1931 for Operations and effective January 1st, 1932 for accountability of rations, funds and property, the following Guardia posts will stand detached from the Northern Area and will be formed into a district known as the District of El Sauce, with Headquarters at El Sauce. This new unit will become a district of the Department of Leon effective on the above date (December 20th):

EL SAUCE  
VILLA NUEVA  
ACHUAPAN  
SOMOTILLO  
SAN FRANCISCO DE GUANIJIQUILAPA

2. Captain John C. McQueen, G.N., is designated as Commanding Officer, District of El Sauce.

3. The Commanding Officer, District of El Sauce will issue the necessary instructions to his post commanders of Somotillo, Villa Nueva and San Francisco de Guanajiquillapa, which lie in the political department of Chinandega, to allow them to deal direct with the appropriate civil officials of Chinandega in all cases involving the civilians living in that portion of the political department of Chinandega lying within the District.

4. PERSONNEL:

a. All Officers and enlisted men now regularly attached to the five posts mentioned will be transferred by staff returns to the Department of Leon as of the effective date, (Jan. 1st, 1932).

b. Authorized strength of posts to become part of the Department of Leon is given as follows:

5. a. The Department, Esteli, will transfer, by invoice, all Guardia property on charge to the units transferred to the Department Commander, Leon, who will take the property up on his property account and account for same to the Quartermaster.

b. Any Marine Corps property that may be affected by the above transfer of units should be reported by the Department Commander, Esteli, to the Quartermaster immediately in order that new receipts may be prepared and credit given to those concerned.

c. Any records or correspondence in the files at Esteli relative to Quartermaster activities in connection with the districts affected and which, in the opinion of the Department Commander, Esteli, would be of benefit to the Department Commander, Leon, in the administration of Quartermaster work should be furnished the latter officer.

GUARDIA NACIONAL DE NICARAGUA,

14 December 1931.

Reference: Orders received from the Department Comdr.,  
10 December 1931.

1. In compliance with the above reference, I and a patrol of forty eight Auxiliars and ten Guardia cleared Chinandega for Villa Nueva at 1500. The Auxiliars were assigned to the Department of Esteli on detached temporary duty and the Guardia transferred to the Northern Area. We cleared in automobiles and trucks furnished through the help of the Jefe Politico. Tires trouble developed at 2330 and an automobile was dispatched to Chinandega to bring back extra tires as replacements which returned at 0230, 11 December, 1931. We cleared at 0345 arriving at hacienda El Obraje at 0445. Preparations were made to feed the men. The Mandador of this place reported all quiet in that section. We cleared at 0545 arriving at Puente Real at 0630. Roads were reported in good condition from Puente to Villa Nueva. Cleared at 0700, arrived at 1300 at hacienda Las Pozas and finding this place deserted. Cleared at 1315. Arrived at Quebrantadero and finding one mozo there who was left when the Mandadors deserted their haciendas as caretaker. He reported as hearing the contact of Licut. Thompson and investigated the following day finding eight dead bodies. Cleared at 1400. Arrived at Hato Grande at 1500 and noticing that there was unusual activity at the hacienda inquired and learned that all of the population of Las Pozas and Quebrantadero were staying at the hacienda and the mandadors of both were making preparations to return to their haciendas the following day. The Mandador of the hacienda Hato Grande reported that numerous groups passed to the rear of his hacienda on the Northern trail the dates of November 26, 27, 28 and 29, all headed North with utmost haste. These groups numbered from three to five. Quite a few cattle was killed during these dates but this stopped as suddenly as it began. Cleared at 1630. Arrived Rio Negro at 1730 and trucks unable to pass guard was posted and proceeded to Villa Nueva arriving at 1800. As per instructions of the Department Commander the patrol was turned over to Lieut. Hutchcroft. I cleared for Somotillo with Licut. Barillas and Guardia at 1100, 12 December, 1931 arriving at 1415. I cleared Somotillo for Aviation field at 0900, 14 December 1931. Planes arrived at 0940 and I cleared for Chinandega arriving at 1030 and reported to the Department Commander.

Extracts from the "RECORD OF EVENTS" of the Eastern Area for the month of November, 1931, states as follows:

TRAINING : Greater emphasis has been laid on open order, combat training, rifle marksmanship and automatic weapons. Recruit training has been held apart as there have been sufficient recruits to form a platoon. School has been held as usual for all Guardia lacking in education with unusual interest shown by the Guardias and Cabo Maestro.

Unemployment continues in the Eastern Area.

Routine patrols along the rivers have been carried out and the usual guards furnished for the various pay-masters on pay trips.

SUMMARY OF FIELD OPERATIONS AND RELATED EVENTS 14 Dec. 1931.

Major Cheatham commanding field operations.

Transport plane arrived with Capt. Good and Capt. Frisbie. Took off for Ocotal and returned with Lt. Jackson (IIC). Frisbie relieved Capt. McQueen who cleared by plane for El Sauce to relieve Capt. Trumble.

Group reported by Estcli at 22.8-41.2 Lt. Zamora and Limay patrol of 25 enlisted cleared. Lt. Livermore heard firing and cleared for same vicinity with 20 enlisted from Limay. Lts Livermore and Zamora returned Limay 13014. Zamora and patrol had contact at 22.8-42.2 with group of 30 under Julian Gutierrez. One bandit killed, three wounded. No Guardia casualties. Bandits scattered and patrols unable to regain contact. Gutierrez is local Jefe who has operated in vicinity of contact for some time.

Lts. Reiner and Rodriguez cleared El Sauce for Managua by plane.

Lts. Hutchcroft, Centeno and Titsworth (IIC) and 36 enlisted arrived Limay from Villanueva at 16014. Hutchcroft to take command District of Limay. Centeno and as many enlisted required to join Livermore's patrol. Remainder of enlisted to garrison Limay.

Leon reports information from Escamilla that Colindres group with many wounded and little ammunition is in vicinity of El Sauce. McQueen notified.

Palacaguina reported five bombs heard in direction Yalaguina between 22013 and 24013.

All stations ordered to send all bandit information to Condega.

Livermore ordered to clear 15 Dec. and comb Arenal-Horno-Jicarito-Pedernal-El Oasis area returning to Limay not later than 18016. (area north Limay).

Holdahl ordered to clear Palacaguina and comb San Andres-Laguna-Casa Blanca area returning not later than 18016 to Palacaguina. (Area South-east Palacaguina).

Frisbie ordered to clear Condega 15 Dec. and comb Pueblo Nuevo-Cerro Grande-San Jose-Laberi to-Colorado-Consuelo-Luje Area, returning not later than 18016. (Area south-west Condega).

Lt. Firth ordered to report to Advanced Area Hdq. as QM field Operations Force.

Holdahl's patrol basing at Palacaguina. Frisbie's patrol basing at Condega. Livermore's patrol basing at Limay.

16 December 1951.

Capt. Frisbie's patrol cleared Condega 07315 on mission assigned southwest of Condega.

Capt. Holdahl's patrol cleared Palacaguina at 07415 on mission assigned southeast of Palacaguina.

Capt. Holdahl reported from Daraili at 17315 area patrolled quiet. No signs or reports of recent bandit activity.

La Trinidad reported Peralta with group of fifty last night at 47.9-23 (McDonald Map), Jinotega notified.

Reliable native returning from Esteli to Ocotal reports Colindres, Umanzor and group passed north of Yali on 7 Dec. heading North or northeast. NOTE: This report has been received from several sources and reports are corroborative. Reports also state that group was well armed, carrying wounded numbered at between three and ten, that blood from wounds was fresh (probably received in Frisbie contact on 5 Dec.), that group numbered between 85 and 100, that group was last seen at Pavona and left there in a northeasterly direction. (Pavona 238-345).

Natives from San Juan de Telpaneca report receiving demands from bandits for contributions. Same natives report that Umanzor has been ordered by Sandino to control the Dipilto area. If this is true it probably indicates that the bandits are going to use the old Ortez camp in the vicinity of Los Arados (192-381).

Telegraph operator at Yalaguina reports firing heard at 10015 between there and Pueblo Nuevo. Yalaguina has a patrol in that section. No further reports from patrol or operator have been received.

El Saucce reports unconfirmed information from Escamilla that Colindres group is hiding in San Nicolas, near Achuapa. Report is being investigated. Believe this to be false information spread by bandit agents to mislead Guardia in view of persistent reports of passing of group through Pavona.

Somoto reports native information that large group, dressed in khaki, passed through Hatillo (179-346) morning of 12 Dec. heading north or northeast.

CO Somoto received warnings from natives to be on the alert. Patrol will make a reconnaissance to the southwest of Somoto 16 Dec.

Daraili reports at 20115 that small group under Reyes Lopez passed near San Jose heading in direction of Las Cuchillas. Rumor unconfirmed. Holdahl will investigate.

Reliable native of Totogalpa who returned from Honduras 14 Dec. reports that bandit agents are gathering large supply of ammunition at Choluteca for movement in near future against Chinandega.

Capt. Holdahl patrol cleared Daraili at 07016 and continued on to Palacaguina at 17016. No information.

Palacaguina reports food supply in vicinity sufficient to subsist patrol of 50 at that station for a period of several weeks if necessary.

Capt. Frisbie patrol arrived Pueblo Nuevo 14516. Covered area assigned, no signs or information of bandits. His patrol will remain in Pueblo Nuevo until morning of 17 Dec., then return to Condega.

Additional automatic weapons and grenade dischargers have been requested for Lt. Livermore's patrol in order to properly equip it.

Lt. Livermore patrol arrived Limay 16416. Covered area assigned. Received information that Gutierrez group which was in contact with Lt. Zamora's patrol on 14 Dec. has crossed into Honduras with several wounded.

Investigation of reported presence of Colindres group in San Nicolas (near Achuapa, Dept. of Esteli) disclosed that group was not there but three graves several days old were found.

CO Jicaro received report from very reliable native that bandit group, armed with rifles, jefe unknown, is killing natives and burning houses near Las Mesas (221-377). Reprisal for attack on bandit foraging group by natives of that section this week which resulted in capturing of one bandit. Jicaro and Apali patrols, augmented by civicos were clearing.

Unless new information is received Holdahl, Frisbie and Livermore patrols will rest until 18 Dec. If the situation does not change it is proposed to start Holdahl and Frisbie patrols to Telpaneca and Palacaguina respectively on that date. Shoes will arrive tomorrow to refit patrols. Disposition of Livermore patrol awaiting decision on auxiliairies.

Later developments make it seem advisable to reorganize Holdahl and Frisbie patrols into three patrols of thirty odd each and start them into the area north of the Coco River between stations Telpaneca, Quilali and Apali.

CO Jicaro reports bandit activity increasing in that section and an exodus of peaceful families to other parts.

The elections in Masaya were all very quiet and in the smaller towns of Granada the voting was without incident. In Granada there was a great of party feeling and although trouble was anticipated, the elections were held without any serious trouble. The voting Urns were collected by the Guardia and held at La Polvera until the time for the Escrutinio by the Alcaldes. Reports of the elections and the escrutinio have been made by separate letters to the Jefe Director.
