MISCELLANEOUS

Captain Small and San Rafael (CA) patrol had two contacts in Pantasma Valley exact locations unknown, on January 7 and again January 9. One bandit wounded in first contact and three wounded in second contact. No guardia casualties.

The following is a report of contact of Captain G. K Frisbie G.N.:

DISTRICT OF QUILALI
QUILALI NICARAGUA

5 January 1932

The District Commander.

The Area Commander, Northern Area, Ocotal, Nic.

Subject:

Report of contact of 26 December, 1931 .

- 1. The patrol under my command designated by the Area Commander as patrol 2-7 cleared this station at 1530 25 December 1931 and proceeded in a notherly direction along the Jicaro River for a distance of 2½ leagues where it made camp for the night. At daylight on the 26th. the patrol proceeded north wading the River Jicaro to a point where the Murra River joins is at 244-372. (See Brig Map) as there are no roads or trails between Quilali and this point travel was slow.
- 2. From 244-372 the patrol picked up a fr esh trail used by bandits leading northeast. At 1100 found "Creek de Oro" which we waded in a northerly direction to about point 251-377 at this point a second trail was discovered, leading to the east in the direction of Chupon (255-378) at about 1430 or later patrol reached the summit of a mountain where breastworks of a crude character had been erected as the opening of a clearing. The patrol reached the edge of this clearing and reconnoitered. A camp in this clearing was detected, several men lounging about same, one below in the field. The bandit in the field detected the Guardia, and the patrol opened fire on the camp and the man below. Firing was short duration, the few bandits in the camp fleeing, firing on the patrol from the brushes as theyran. Two were killed and the one below the camp wounded, who escaped. His wounds are believed to have been fatal, due to the loss of blood and the manner in which he fell when struck.
- 3. This camp was destroyed by fire, four explosinns occurring coused by dynamite bombs, several more caused by cartridges. The following articles were captured: Small quantity of ammunition, one rubber stamp used for stamping letters "Departamento de Armas Nueva Segovia", three animals, and correspondence disclosing plans to ambush trail between Quilali and Jicaro, no date specified, including a letter addressed to "Major Rafaél Altamirano" signed "A. C. Sandino" and dated 24 Dec. 1931.
- 4. One prisoner was captured, wife of Rafael Altamirano who disclosed that "General Colindres" and between forty and
 fifty men arrived after dark at this camp on 24 Dec 31 armed with
 three automatic weapons, six pistols, balance with rifles and
 spent the night leaving at daylight xmas morning for Sandino,'s

camp, there to include Sandino and woned go south into the district of Jinotoga where large gifts of tribute were expected. The correspondence, as was Sandino's letter, was nearly all addresed to "Sgto Mejor" and "Major Refael Altemireno" at his comp" the presence of the correspondence and his wife word normally indicate this camp to be that of Altemirano. Such I. Baliswe was the case. Following this reasoning, the bandit wounded in the cornfield would seem very probable to be Refael Littricane, inasmuch as the camp was his, his wife, later positively identified as such, present along with Sandinos letter Addressed to him of such recent date. However to the undersigned tends to confor in the other facts brought out. However, the identity is problematical. The Sandino letter was short and domanded elterizane to produce the explosires, bringing there to the "Guartal General" at once.

- As soon as practicable the patrol proceeded eastward towards "Chipon" the reported headquarters of General Sandino in the Chipote regions. Spent the night enroute. At Englight on Dec 27, 1931 proceeded eastward using woman prisoner as a guide who conducted the patrol to a camp which she averred Ils Squaine S the Quartel General she disclaimed knowing. Those carps contained 100 bushel corn each, camps were destroyed. Encry effort was noted during the remainder of this day to uncover larges camps in this area which the prisoner indicated was "Chipon". Enery trull was investigated without revealing further camps. The jungle in this region as well as esery part of the terrain traversed since laaving Quilali being almost imponetrable, further secreting saming to be impracticable, the patrol worked further north in stayings of orders, Spont the night enroute and on Doe 28 1931 arrived at/252-385 the fortheast point north. The patrol found itself in an unknown wilderness and until dark on this date did no know its whereabouts.
- 6. At 1100. 28 Dec 31 the patrol entered a electing containing a large camp itsey and about 100 lbs. beans, seweral additional bombs exploded where this camp burned. It contained sleeping space for about thirty and had been occupied within 48 hours. Proceeded south and west. Entered destroyed three additional camps, each of which contained dynamite bombs which exploded upon burning the camps. Several of these camps were of fairly gord construction, being of split cedar shingle roofs. All had fields nearly of corn and sugar cane. Distroyed one field of tobacco. The patrol reached the northern tier of Chipote and camped for the night at Naranjal.
- 7. Patrol cleared at daylight for and reached Quilali at 1630 29 December 1931. The patrol's morate remained excellent in spite of the long hours of patrolling where neither sky nor landmarks could be ascertained. I gave each nan 10 gr. quinine sulphate upon retiring each night undoubtedly assisted in preventing sickness as the patrol slept and marched in wet clothing. The patrol arrived at Quilali nearly spent with but remaints of their clothing remaining on their backs.

Contact with small group bandits, report of.

1. Upon the receipt of information from Indians that a large group of bandits had crossed Laimus Creek and proceeded in an Easterly direction, myself and the following enlisted cleared Kisalaya to reconnoiter area down river:

2. About one and one half mile South of Kisalaya patrol picked up trail of bandits proceeding in the direction of Waspan; patrol followed clearly defined trail to Waspan Creek, when it becameevident that bandits had cut trail thru dense underbrush towards the mouth of creek. Patrol followed and upon arriving within one hundred yards of the position taken by bandits, a warning was given them by someone some twenty-five yards from patrol with the firing of a pistol. Patrol approached with caution thru dense underbrush and opened fire in the general direction of bandits. Upon arriving at the mouth of Waspan Creek, where it flows into the Coco River, a clearly defined target of five bandits were found in a pitpan, attempting to escape towards the Coco River. Fire was immediately opened up on pit-pan with the result that in their

haste to escape pit-pan was overturned, and as they attempted to climb steep bank, three were killed and fell into the river. Patrol returned by same trail towards main trail to Waspan, and found bandit that had given signal badly wounded; we carried wounded bandit in the savanas, some hundred yards from main trail; his pistol was still in his hand. Myself and Sgt. Jiminez questioned him, and his answers is herewith attached, in as far as I am able to recall from memory.

- While Indians reported a large group had crossed Laimus Creek, patrol found upon investigation no more than a group of fourteen under Chavarria, who offered but slight opposition and little leadership. At the completion of questioning patrol cleared towards Saupuca, but did not again gain contact with bandits. Laid ambush near Kum, but bandits did not come near.
- 4. The conduct of this patrol was all that could be required under the circumstances.
